#### Undergraduate SART Research Assistant (not a paid position; available for course credit)

We are conducting a national study of Sexual Assault Response Teams (SARTs). SART teams bring together nurses, police officers, advocates, and other community service providers in collaboration in order to improve the response to sexual assault victims and the prosecution of sexual assault offenders. We hope to use our study's findings to inform SARTs' practice nationwide. Some of the data we are collecting is numeric, while some of the data captures participants' views and experiences regarding SARTs.

We are looking for students to serve as research assistants for summer 2012 and/or fall 2012 for 7-10 hours per week. Please note that this is not a paid position. You may volunteer or receive research credit through PSY 490 (see http://psychology.msu.edu/Undergrads/GetInvolved.aspx for eligibility criteria for 490 credit). Responsibilities will include transcription of open-ended (non-numeric) data and discussion of the data. If time permits, you may also be able to be trained in qualitative data analysis (meaning coding the data for patterns or themes). You may also be trained to help with managing numeric data. We also ask that you attend weekly teem meetings. Why Work with Us? This is a great way to get some experience in community based research AND receive PSY 490 credits. A major in psychology is NOT required. This project would also be a good fit for someone who wants to learn more about collaboration, qualitative data analysis, or the response to sexual assault. #### Gender Neutral Housing approved at MSU for Fall 2012

The new flexible housing option, which will allow some on-campus residents to live with members of the opposite sex, is expected to be implemented as a pilot program in some suite-style rooms in **West McDonel and North Wonders halls**, said Kathy Collins, Director of Campus Living Services and Residence Life. The policy aims to benefit students who wish to live with family members, have disabilities that require living with a caretaker or who feel more comfortable living with a member of the opposite sex. With about 80 spaces available in the residence halls, Collins said she expects flexible housing to expand after the first pilot year.

#### *Race, Resistance, and Reason: Rethinking the Boundaries* SUNY at Cortland, October 20, 2012

#### Abstract Deadline: June 15

Race matters. In the wake of the racialized responses to President Obama's administration, Islamophobia, reemerging orientalism, immigrant policing, and the perpetuation of poverty in our global communities of color, we call you to join us in a conversation about race, resistance and reason. This conference seeks to create a space to rethink the boundaries of race, resistance and reason globally and at the level of lived experience. Participants are invited to share scholarship and articulations of the tensions between the consequences of a racialized body, a strong political identity that is tied to race, and the tensions that are experienced at the intersections of race, gender, sex, sexual orientation, class, and ability. Equally important, we hope that this conference will serve as a space to think about the resistances to hegemonic categorization, naming and normative ideas of reason and thought that we know are inheritances of race and racialized, gendered bodies. Submissions: Papers, artistic presentations, performances, and workshops may address, but are not limited to the following possibilities: Social constructions and lived realities; Teaching race in the classroom; Islamophobia: The new ground zero; To end racism you must end homophobia: Intersections of race and orientation; Crossing Borders: Reclaiming identities and spaces; Naming the self, resistant identities; Foundations of Reason: The Prison Industrial Complex and other institutional reinforcements of race (military, education system, healthcare); Panafrican understandings of race, resistance and reason; Ideologies of citizenship and/or civility; Hip Hop and reason; Masculinity. and its Other; Indigenous women and men contesting colonial normativity; Asian Americans resisting model minority myths; Performances of race, gender, sex and sexual orientation; Articulating racism as white supremacy; Reason and Thought: Normativity, understanding and performance fiction, storytelling, performance; Subversive Mothering: Homeless, migrant, immigrant mothers; Third Space, bridges and borderlands; Race Bending: resisting binary reason; Transgenerational impact of race; Trans-raced and Trans-reasoned; Activism, advocacy, and social welfare; Diversity and multiculturalism: anything but race. #### Signs Special Issue: Women, Gender, and Prison: National and Global Perspectives Application Deadline: June 30

Despite neoliberal commitments to cut back the state, during the last decades of the twentieth century many states dramatically increased spending and infrastructure development on policing, imprisonment, and the military. Initiatives designed to get tough on crime, wage war on drugs, suppress dissent, militarize borders, and criminalize migration contributed to major growth in the prison population. In striking contrast to earlier eras, the growth rate for women's incarceration has outstripped men's. Since 1977, the population of women in U.S. prisons has increased roughly 700%; in Britain, it has grown by 200%. Ethnic minority women are drastically overrepresented in prison populations, as are women who have suffered physical and sexual abuse. Imprisonment poses unique challenges for women, particularly with respect to reproductive rights and freedoms, childbearing, and childrearing. The exponential increase in women's incarceration also coincided with the privatization of prisons and the emergence of new gendered divisions of prison labor. The "war on terror" has fostered a "war on immigrants," and increasing numbers of women have been held in detention without charge on suspicion of terrorist connections or immigration violations. For this issue, submissions are sought that address women's imprisonment and detention, including gendered carceral regimes, challenges to bodily integrity, reproductive freedom, and mothering in prison; the effects of imprisonment on families and communities; the relationship between the welfare state and the penal state; the social, economic, and political mechanisms that generate punishment of women; and the effects of race, ethnicity, class, nationality, sexual orientation, and transgender on experiences of imprisonment and practices of punishment. The issue is scheduled to appear in Winter 2013.

#### Journal of Leisure Research Special Issue on Feminism

Researchers are invited to submit manuscripts that explore and utilize feminist theories and methodologies broadly defined, within leisure scholarship. Feminist research within leisure studies is at a critical juncture. As pioneers of feminist leisure research retire, there is a need to celebrate and highlight the vast array of leisure scholarship that continues through a feminist lens and chart new directions in an ever changing field. This special issue will harness the energy of current feminist leisure research, highlighting its breadth, depth, and diversity. In so doing, we aim for the special issue to serve as a galvanizing force by creating a community of new and established feminist leisure scholars who can network, strategize, and take action together in both research synergies and other more tangible ways. Grounded firmly in third wave feminism, the special issue will explore the intersections, transformations, and innovations in feminist ways of thinking and conducting research. Moreover, the special issue aims to highlight and discuss the complexities and contradictions that exist within third wave feminism. The special issue will create a space for reflection and reinvigoration of feminist debates and directions related to diverse methodologies, conceptual traditions, and ways of writing through gendered leisure. Authors (including those in post-doctoral positions and new graduate students) are invited to submit manuscripts that include empirical studies from a broad range of feminist theoretical orientations, which may also be combined with similarly informed perspectives (queer theory, gender theory, post-colonial theory, postmodernism, feminist masculinities, etc). Conceptual discussion focused on policy, activism, and politics is also welcome. We invite contributions from a broad range of substantive topics,

approaches to conducting and representing leisure research, as well as multidisciplinary perspectives (women's studies, geography, sociology, psychology, cultural studies, history, economics, environmental studies et al). All contributors need to ensure that submitted articles have a feminist focus that explores leisure as a broad or specific context (tourism, events, sport, recreation, parks, the arts, pop culture) within the context of debates in the literature. Submitted manuscripts will undergo the normal review process and should adhere to the "Instructions for Authors" as outlined by the Journal of Leisure Research. Men and Masculinities seeks empirical and theoretical articles, written for a multidisciplinary audience, that explore issues in masculinities. Topics of particular interest include: constructions of masculinities; male/female relationships; sexual behavior or sexual identities; representations of gender; diversity among men and intersections of race, ethnicity, sexuality, age, class, and masculinities. The journal subscribes to principles of non-sexist, non-heterosexist, and non-racist publishing, and the editors are also committed to publishing significant empirical work that challenges conventional wisdoms. Book reviews and essays are also welcome. Authors should submit their manuscripts through our online submission site (listed above). Manuscripts should conform to relevant stylistic guidelines of the Chicago Manual of Style, Documentation 2 (15th edition). Each manuscript should be accompanied by a title page including complete author name(s), affiliation(s), mailing address, phone, fax, and email information (for multiple-author papers, provide complete information for each author and indicate the corresponding author). There is a requirement of up to 30 pp. per manuscript, including references; each manuscript must also be double-spaced, font size 12, with at least 1" margins (for ALL margins). Submitted articles will undergo blind peer review. Authors are requested to place no form of identification either on the body of the manuscript or on the required abstract of 150 words or fewer and to remove any tracked changes from the electronic copy of the manuscript. A biographical note of 100 words or fewer, indicating the author's affiliation, research interests, and recent or major publications should accompany the manuscript. Submission of a manuscript implies commitment to publish in the journal. Manuscripts should not be under consideration by any other publishers while being reviewed by Men and Masculinities or have been published elsewhere in substantially similar form or with substantially similar content. Every effort will be made to complete the editorial review process in a timely manner. Submitted manuscripts will not be returned.

It also publishes poetry, film and book reviews. *Women's Studies* receives all manuscript submissions electronically via their ScholarOne Manuscripts website listed above. Preparation of Manuscripts: *Women's Studies* accepts original articles of between 20 and 30 (double-spaced) pages in length. We also accept short prose pieces of varying length (not to exceed 20 pages) and poetry. All manuscripts should be submitted as Microsoft Word documents, double-spaced with standard font. Number manuscript pages consecutively throughout the paper. Authors should also supply a shortened version of the title for a running head, not exceeding 50 character spaces, an abstract of approximately 100 words, the author(s) affiliation and location. Please also include a cover letter stating that the article has not been published elsewhere, nor is it under consideration for publication elsewhere. HST 208: Introduction to African History, Culture, and Society. This online course is a general survey of the history, culture, and society of Africa. It will explore the interplay between the internal as well as the external socioeconomic, political, and religious forces operating in African societies slightly before and after 1500. Each week we will concern ourselves with exploring the main political, economic, religious, and social currents of Africa and how Africans have sought to adapt to and reshape external forces imposed by colonialism, Western Capitalism, Islam and Christianity. The course presupposes no background in African History, therefore during each session the instructor will offer a lecture and overview that will provide a historical narrative of a given African theme.

HST 361: African History Since 1800, MW 9:10am-12:00pm, 106 Ernest Bessey Hall

This lecture course examines the internal dynamics of African history beginning from the nineteenth century, as well as the processes by which Africa became integrated into the larger world system. The course is organized into a series of general topics arranged in a roughly chronological order and will also explore the interplay between the internal as well as the external socio-economic, political, and religious forces operating in African societies since 1800. We will concern ourselves with exploring the main political, economic, religious, and social currents of Africa and how Africans have sought to adapt to and reshape external forces imposed by European exploration and colonialism, Western Capitalism, Islam and Christianity.

**Poverty & the American Family: A Multimedia Exploration: SW290** section 732, 3 credits. Combining multimedia resources like YouTube clips, a New York Times bestselling book, current newspaper articles, a PBS documentary, and even an online game, this course is an introduction and exploration of poverty in America and the impact of poverty on American families and children today. The course will begin with a broad overview of poverty across the US (how it is defined and measured, indicators, trends, current policy, etc.) and narrow to focus on Michigan (how Michigan compares to other states, new lifetime cash assistance limitations, etc.), culminating in final student-prepared briefs on the status and impact of poverty within selected Michigan counties.

**Substance Abuse & the Human Services: SW474** section 730, 3 credits. This course is designed to provide students with an introduction and broad overview of substance use/abuse as it affects individuals, families, communities, social policies, and practice. Included in this course will be attention to: substance abuse (epidemiology) from a global perspective; the process and nature of substance abuse/chemical dependency; harm reduction as a philosophical framework; an overview of contemporary treatment models; historical perspectives on chemical dependency and social responses; and the role and need for advocacy within this area of human service help provision.

**Trauma Across the Lifespan: SW491** section 732, 3 credits. Trauma permeates our world and technology brings it right to our doorsteps, yet its impact and devastation are not largely understood. Turn on the television, pull up a newsfeed, open a newspaper: all offer daily examples of trauma and its impacts. This course will look at the impact of traumatic events on individuals across various stages of the lifespan. Students will gain knowledge of various types of traumatic experience as well as an understanding of how to help and interact with people who have experienced trauma, and the personal impact of working with individuals who have experienced trauma. We will explore biological, psychological, and sociological dimensions of traumatic experiences on individuals and systems. Areas of child abuse and neglect, grief and loss, terrorism, disasters, war, and refugee trauma will be addressed.

#### Full Session:

**Child Welfare: SW471** section 731, 3 credits. In this course students will examine the history, evolution, and functions of child welfare social work practice. We will explore risk and protective factors related to child abuse and neglect while developing a foundational understanding of issues related to race, age, gender, culture, and socio-economic status. Key legislation and policy will be reviewed with an emphasis on contemporary issues impacting children and families being served in the Michigan child welfare system. Students will identify evidence-based interventions appropriate for children and families and create advocacy projects to address the unique real-world needs of this client population. This course offers a collaborative learning environment that invites students to take an active role in exploring social work policy and practice structures that are carried out within child welfare settings.

#### **MSU Department of Sociology Summer Online Course**

#### Summer Session I: May 14- June 28

The MSU Department of Sociology is offering SOC 490, Section 731: "Climate Change and Society" as a summer online course for the first summer session. Climate change is one of the most important societal challenges of the 21<sup>st</sup> century. This course comes at a time when there is a strong scientific consensus on the issue but public opinion is divided and policy debates are sharp. The course will use text, art, photography, film and cultural representations to familiarize students with our current understanding of climate change, its potential impacts and the approaches that can be used to both adapt and limit the magnitude of the effects. In addition to increasing substantive knowledge, the course will encourage students to reflect on their own values and beliefs and to learn to engage in constructive dialogue. Published by the International Center for Research on Women (ICRW), this report is a comprehensive synthesis of results from ICRW's International Men and Gender Equality Survey. Administered between 2009-2010, IMAGES is a paper questionnaire on men's behaviors and attitudes towards women, and women's opinions of it. The survey was given to participants in India, Chile, Croatia, Brazil, Mexico, and Rwanda. "Evolving Men" sums up the responses of those participants and provides a snapshot of gender equality in the developing world today, and what can be done to improve the lot of women everywhere.
