The author’s research in Tanout, Niger, has shown that resources, rights, and responsibilities in pastoralist households are gendered in negotiable partnerships between hearthholders and chief herders. Through a successful partnership, essential for the viability of household enterprises, wife, husband, and children benefit from livestock and dairy production to maintain the household’s overall well-being. Correspondingly, this paper illustrates that programs that disregard these partnerships and household/herd integrity risk failure and harm to project participants. ### ***Knowing in Space: Three Lessons from US Black Women’s Social Theory***

In attempting to create a US Black feminist philosophy, Professor Dotson has uncovered three lessons in US Black women’s social theory. They are the following: **1)** oppression is a multistable, social phenomenon; **2)** many US Black women identify occupying a negative, socio-epistemic space as part of their experience of oppression; and **3)** addressing oppression for many black women will require grappling with politics of social

spatiality. These insights are by no means new. However, the fact that these tropes can be identified in almost 200 years of black women's social theory in the US is far more distinctive than many allow. In this presentation, Dotson will offer an articulation of each of these three lessons concerning social oppression and begin a discussion about US Black feminist philosophy.

***Health Disparities Among Same-Sex Couples***

A legacy of research finds that marriage is associated with good health. Yet, same-sex cohabiters cannot marry in most states in the U.S., and therefore may not receive the health benefits associated with marriage. This study utilizes pooled data from the 1997-2009 National Health Interview Surveys to compare the self-rated health of same-sex cohabiting men (n = 1,659) and same-sex cohabiting women (n = 1,634) with that of their different-sex married, different-sex cohabiting, and unpartnered divorced, widowed, and never married counterparts. Results from logistic regression models show that same-sex cohabiters report poorer health than their different-sex married counterparts at the same levels of socioeconomic status. Additionally, same-sex cohabiters report better health than their different-sex cohabiting and single counterparts, but these differences are fully explained by socioeconomic status. Without their socioeconomic advantages, same-sex cohabiters would report similar health to those non-married groups. Analyses further reveal important racial-ethnic and gender variations.

The FLAS Fellowship program is designed to meet critical needs for specialists in American education, government, and other services of a public and/or professional nature who will utilize their skills in training others and in developing throughout the United States a wider knowledge and understanding of other countries and cultures. CASID/GenCen's FLAS Fellowships are awarded to graduate students enrolled in programs that combine the study of a modern foreign language with advanced training and research in international development studies. Academic year fellowship support includes the payment of tuition and fees (up to \$18,000 per academic year) and a stipend of \$15,000. Summer fellowship support is available to graduate students enrolled in intensive language programs at MSU, other U.S. institutions and overseas. To be considered for fellowship support, you must: 1) Be a citizen or national of the United States, a permanent resident of the United States or a permanent resident of the Trust Territory of the Pacific Islands. 2) Have earned a baccalaureate or comparable degree before the fellowship period begins and be admitted to or currently enrolled in a graduate degree program at Michigan State University. 3) Intend to complete an advanced graduate program (disciplinary, interdisciplinary, professional, doctorate or masters) at Michigan State University with a concentration on international development. 4) Show potential for high academic achievement, as evidenced by such indices as grade point average or other measures.

Applicants must agree to pursue full-time graduate study and propose a course of study that includes both language training and international development course work. Students at the dissertation stage must engage in full-time research and utilize the foreign language for the research. Applications are available at the link above.

### **Call for Nominations: Richard Lee Featherstone Endowed Prize**

Application Deadline: **January 25, 2013, 5:00pm**

The Richard Lee Featherstone Endowed Prize seeks to identify the most outstanding graduating senior, based on the criteria below, and to grant an award to be used for "future growth and development, travel, graduate study, or meditation," to quote one of the Prize founders, Gerald Faverman. In 2013, the amount awarded will be \$4,000. **Selection Criteria:** 1) The award recipient must be an MSU senior, majoring in any discipline, who is expected to graduate during 2013 (Spring, Summer, or Fall). 2) The award recipient will exhibit an open, curious, creative approach to education and ideas, and intellectual ingenuity will be evident. More weight will be given to intellectual curiosity and innovation than to grades attained, although a cumulative GPA above 3.0 is preferred. 3) The award recipient will have demonstrated exceptional character and leadership in furthering her/his own progress and in enriching the lives of others, especially in intellectual and international dimensions. She/he will have utilized innovative approaches in these efforts. A commitment to community service and to lifelong learning should be evident. **Nomination Procedure:** There is no nomination or application form. Each nomination packet should include: 1) One letter of nomination from a Michigan State University faculty member and, although not required, up to two additional letters in support of the nomination from Michigan State University faculty members. 2) An essay or letter of not more than 1,000 words written by the student. The student's name, PID, address, telephone number, and email address must be included on the student's submission. 3) Student's resume. The nomination letter, support letters, student

essay, and student resume should address the ways in which the student exemplifies the award criteria. Specific examples of activities and achievements are especially helpful to the selection committee. Nomination packets, including the student's essay and resume, should be delivered to the Office of the Associate Provost for Undergraduate Education and Dean of Undergraduate Studies, 312 Hannah Administration Building. Finalists—selected by a committee designated by the Board of Directors of the Featherstone Society in conjunction with the Associate Provost for Undergraduate Education—will be notified by February 22, 2013. Finalists' interviews will be held on Friday, March 22, 2013. Notification of the award recipient is planned for Friday, March 29, 2013. A luncheon for the nominees and nominators is planned for April 23, 2013. The presentation of the Featherstone Prize Award plaque to the recipient takes place at the appropriate commencement/awards ceremony. The conference began in 1993 with a group of dedicated students who wanted to create an unquestionably interdisciplinary conference able to accommodate both traditional and non-traditional topics and presentations. Since that time the conference has remained student-oriented, open to undergraduate and graduate students, as well as recent graduates. In the past twenty years, *No Limits* has hosted hundreds of presentations from students and community members involved in Women's and
