Dr. Moghadam is Director of the International Affairs at Northeastern University and focuses on sociology and development. Dr. Rakowski is an Associate Professor of Women's Studies and Rural Sociology at Ohio State University, and her work is on sociology and women's studies. Dr. Van Vleet is the Director of the Latin American Studies Program at Bowdoin College, and is based in anthropology. Dr. Brooks is an Associate Professor of Sociology and Women's Studies at Rutgers University, and her work is also on sociology. Dr. Parpart is a Professor of History at Dalhousie University, and focuses on conflict and peacekeeping as well as international relations and gender. Dr. Duvvury is the Co-Director of the Global Women's Studies Programme at the National University of Ireland, Galway, and her area of expertise is economics. Dr. Haarr is Professor of Criminal Justice at Eastern Kentucky, and looks at human trafficking and violence against women. Dr. Hodgson is Professor and Chair of the Department of Anthropology at Rutgers University, and looks at development, religion, and transnational politics. Sexual Orientation, Gender Identity, Sexual Politics, and Multiculturalism in Amsterdam, July 12-Aug 11, 2013 In this program, students will learn about sex and gender politics and policy in the Netherlands, one of the most sexually liberal countries in the world. This nation was the first to legalize same sex marriages, grants sex workers legitimate status, and covers sex reassignment surgeries through its government health plan. Yet tolerance for sexual and gender diversity is counter-balanced by a pervasive social intolerance of Muslim immigrants. Students will study sexual and gender politics with Dutch scholars and speakers working in organizations relating to sex workers, sex education, transgender advocacy, and LGBTQ rights in order to advance their knowledge of these topics in a comparative context.

Students will reside in the vibrant city of Amsterdam, where world-famous museums and cafes abound alongside beautiful canals and historic architecture. Students will be housed in dormitories at the University of Amsterdam. Excursions may include a visit to a sex-reassignment clinic, a guided tour of the Red Light District, and a trip to the World Population Fund Center for Sexual Education in Utrecht. Students will also have the opportunity to visit Brussels, where they may meet with LGBTQ refugees and representatives from the International Organization for Lesbian and Gay Rights.

To Make Their Own Way: African American Female Labor in New York City's Informal Economy, 1900-1939

This presentation examines and documents the intriguing lives of an all-too-often neglected segment of urban workers: black female underground economy laborers in New York City. During the first four decades of the twentieth century, these women carved out niches for themselves within the city's noteworthy informal economy. This presentation investigates the complexities of black women's various occupations as number barons and runners, spiritual mediums and healers, and sex workers. While this study focuses on the nuanced sub-culture of black women in New York City's informal economy, it also delves into how their lives and choices were perceived by black and white social reformers as well as their varying interpretations of labor and identity, appropriation of public space, and their notions of what Evelyn Brooks Higginbotham and others have theorized as the politics of respectability.

Legal Inroads to Interracial Desire: The Erotic Panoply of Rhinelander v Rhinelander (1925)

"So the stage is set for the most sensational moment of the trial this morning, with the odds favoring a continuation of the suit. The courtroom doors, which have been stormed every day by a fighting crowd, will face an even larger and determined mob this morning" (New York Times, Nov. 20, 1925)

"The testimony at the beginning of this week with the disrobing of Mrs. Rhinelander and the reading of Kip's unprintable mystery letters which threatened to halt the suit last Thursday has been of a nature that revealed the most outrageous and disgusting filth that probably has ever been heard in a courtroom" (Chicago Defender, Nov. 25, 1925)

This paper closely examines the Rhinelander annulment suit of 1925 as a microcosm of race, erotics and the law working in tandem to uncover public anxieties, irrationalities of the law, a surplus of pleasure, and the racial politics of voyeurism. Law enforcement officials were able to use legal precedent as justification for forcing Alice Rhinelander to disrobe in judge's chambers to "prove" her racial heritage. In addition, both attorneys entered as evidence and read aloud in court over four hundred love letters written by Leonard and Alice during their relationship. This excessive pursuit of evidence suggests that establishing a strong case for an annulment provided the perfect alibi for overindulging in interracial sexual fantasies. Indeed, public fascination with the case, newspaper accounts of the couple's deviant sexual relationship, and the trial transcripts all demonstrate how both prohibition and desire generated public spectacle.

Tracy Dobson Award for Undergraduate Student Feminist Activism

Submission Deadline: November 15

The Center for Gender in Global Context invites submissions for this award, named to honor Tracy Dobson's tireless efforts to bring gender equity to MSU, launching MSU's enhanced plan to recruit and retain women faculty and administrators. Her commitment to inform and inspire students to work for social justice led many to law school and to seek careers in public service through elected positions or the non-profit sector. Professor Dobson retired in 2011 from MSU's Department of Fisheries and Wildlife. The award honors an MSU undergraduate who has distinguished him or herself through exemplary local, national, or international activism on behalf of gender equity and social justice. The award will recognize those who have achieved a leadership position on behalf of their chosen cause. Evidence of commitment to a feminist cause through the college career as well as dedication to a career in some aspect of gender equity and social justice is required. To apply: please submit CV/resume and a three-page description of the feminist cause you have been involved in and your role in it. Two letters of support—from a supervisor, co-worker, peer activist or MSU faculty or staff mentor—are also required in support of your application materials.

Submissions will be reviewed by a faculty committee, and the award will be presented at the annual GenCen Open House in January. The award winner will receive a \$200.00 prize.

MSU Student Health Services are available to MSU and MSU Law students.* The first three medical office visits of each school year are pre-paid for enrolled MSU students (MSU Law, Lifelong Ed students, and students in the fifth (internship) year of the Teacher Certification Program are not considered enrolled MSU students). Additionally, the first three lifetime psychiatry visits are offered prepaid by the University for enrolled MSU students. Laboratory, x-ray, pharmacy, physical therapy, medical supplies and medical/surgical procedures are not considered part of the prepaid office visit. Student Health Services will bill for these charges as well as for the fourth and subsequent visits.

Unenrolled students (for one semester), spouses of students, Lifelong Education, and MSU Law students will be charged for all office visits. Visitors enrolled in University-sponsored programs and University employees with work-related concerns may be treated on a fee-for-service basis.

* In addition, Student Health Services provides services on a fee-for-service basis to adult family members of MSU and MSU Law students. The services provided to adult family members of MSU and MSU Law students are not a benefit as described in the September 12, 1997 Board of Trustees resolution regarding Domestic Partner Benefits.

The undergraduate application for admission to the Teacher Preparation Program, for Fall 2013, is available via the College of Education's website, September 4 through November 28. Applicants will need Adobe PDF Viewer to access the online application and the additional paper materials that may be required. Note: the target audience is primarily sophomores and above but freshmen/first year students with substantial AP or dual enrollment credits may also be good candidates to apply. Interested students who can be at junior status by Fall 2013 are encouraged to apply this fall.

This fall's applicants, as in the past, must either have already passed the Michigan Test for Teacher Certification (MTTC) <u>Basic Skills test</u> (all three parts: reading, writing, and math) OR must register for, take, and pass the upcoming <u>October 13 OR November 10</u> test. Students can register for the Basic Skills test online at **www.mttc.nesinc.com** and should be sure to select MSU to receive an official score report.

Other admission requirements include: GPA of 2.75 or higher by the end of the current fall semester; Passing of any required remedial/developmental courses in math (e.g., MTH 1825) or writing by the end of the current fall semester; Successful completion of the web-based, proctored application essay (essay date and time arranged through the on-line application); Students admitted for Fall 2013 must be at junior status or higher (56 earned credits) by the end of summer 2013.

For current juniors or seniors wishing to accelerate their teacher education program in order to intern teach by Fall 2014: submission required of an acceleration planning grid (available via the application website) to show plan to complete all degree and teacher education undergraduate requirements by summer 2014. **Note:** students must make an appointment with an academic advisor for the desired major to evaluate and approve their plan to accelerate. Case studies will focus on Senegal, Mali, Niger, Nigeria, Mayotte, Kenya, Sudan and the Americas. We will visit the Islamic Center of East Lansing, watch films, follow the media portrayal of Africa, and hear alternative narratives of Islam in Africa from guest speakers. MSU Spring 2013 course: GEO 492, Section 001: *Geophysical Research Problem (Severe and Hazardous Weather)*

Tuesdays and Thursdays, 1:00-2:20 p.m., 126 Geography Building, Professor Lifeng Luo
The year 2011 brought some of the worse severe weather we have seen in the last decade, including the
blizzard that buried Chicago, the record tornado outbreak across the Southeast US in April, the massive
flooding on the Missouri River and the lower Mississippi River, and the devastating drought and fires that laid
waste to much of Texas and the Southwest. The goal of this *Severe and Hazardous Weather* course is to
provide students with a current, relevant and scientifically accurate discussion of all types of hazardous
weather. Discussion topics include extratropical cyclones, freezing precipitation and ice storms, lake effect
snowstorms, cold waves, blizzards, thunderstorms, tornadoes, downbursts, tropical cyclones, floods, drought
and heat waves. Through this course, students will gain a basic understanding of severe and hazardous
weather, and develop an appreciation for the complexities and power of severe weather. In a more practical
vein, students will become better prepared for severe weather, more aware of what is happening when
severe weather threatens, and better able to react when severe weather strikes.

Evolving Men: Initial Results from the International Men and Gender Equality Survey (IMAGES)

Administered between 2009-2010, IMAGES is a paper questionnaire on men's behaviors and attitudes towards women, and women's opinions of it. The survey was given to participants in India, Chile, Croatia, Brazil, Mexico, and Rwanda.
